ARTS AND CRAFTS EXHIBITOR INFORMATION

The Clifton Day Festival is a one-day music, arts and crafts and antiques extravaganza. Located just outside Washington, D.C., Clifton

Day attracts more than 25,000 visitors each year. This year marks the 44th annual Clifton Day. All Arts and Crafts exhibitors are juried. Selection of exhibitors will be based on the nature and quality of work represented and overall presentation and display as represented in submitted photos. The jury will consider how the work fits into the show, assuring diversity within and across categories. All arts and crafts must be created and displayed by the exhibitor. No buy/sell pieces are allowed. For buy/sell pieces, request an application for the Town Market at 703-968-0740, or download one at www.cliftonday.com

EVENT DATE

Sunday, October 9, 2011 (always the Sunday of Columbus Day weekend). Rain date: Sunday, October 16, 2011.

HOURS

Official show time is 9 a.m. to 5 p.m., or until streets are cleared of patrons. No set-up or break-down between these hours. You may set up anytime after 6 a.m. but **no selling is allowed until you are set up and your vehicle is moved**. No vehicles have access to the town after 8 a.m.

JURY CRITERIA

Only quality handmade arts or crafts produced by the vendor will be accepted. Selection of exhibitors will be based on the nature and quality of work. Please submit three color photos that will allow jurors to best view your work, plus one photo of your display, each labeled with your name. Photos will not be returned. Color copies are acceptable but must be of good quality. Exhibitors may only sell work that is represented in the photos. The jury reserves the right to make selections based on the needs of the show for diversity within and across categories.

DEADLINE

July 15, 2011 is the deadline for applications. After that, applications will be accepted on a space-available basis.

CANCELLATIONS

A full refund will be made if cancellation is made in writing prior to Sept 1, 2010. After Sept 1st, no refunds will be made.

SPACES

Space sizes vary but will be no less than 10x10 ft. on streets and in parking lots. We have no indoor spaces. Each exhibitor is required to furnish their complete display. No electrical hookups are available. If you wish to request a particular space, feel free to do so. Spaces are assigned according to the distribution of exhibition categories as deemed necessary by the jury. Please understand that many factors contribute to ultimate space designations.

UNLOADING AND SETUP

There is no check-in process. Vendors should drive directly to their spaces and unload. Exhibitor and parking spaces will be pre-assigned and a map will be sent to each exhibitor with space numbers and map of Clifton Day.

PARKING

Parking is not permitted in show spaces. Some spaces have parking nearby for handicapped exhibitors with valid handicapped parking permits. However, these are limited in number. Please follow the instructions of Clifton Day staff and park where directed after you unload.

SHOW FEE

\$100 per outdoor space. Up to two spaces may be requested.
